#### Accounts:

Administrative office is using tally software to maintain the books of accounts. Proper training will be given to Accounting staffs to maintain the financial records effectively. Training to the existing staff and up-gradation of the existing software must be done regularly. Appropriate security measures should be taken for maintaining confidentiality of all the financial transactions. All the scholarships from the government and other agencies are received and managed by accounting department effectively. The CMS system established in the college helps to automatically calculate salary considering the HR policy of the institution regarding leave and other deductions like TDS, Provident Fund, ESIetc. The salary is directly credited to the employees' account and other payments are generally made and received through online mode.

#### Library:

Our institution maintains a well equipped library with the required numbers books and journals to ensure academic excellence. In addition to that, a well stocked general books also available for the benefits of students and faculty members. Our Library is working between 9.00 am to 8.00 pm on all working days, Students and staff members' attendance is marked using the Library software called campus i lib. The institute is taking all necessary steps to incorporate library operations with CMS. The issue registers are replaced by the software and the circulation is properly maintained right from creating member records to printing of reminders foroutstanding books. It subscribes national and international print periodicals, DELNETs, IESTC, IMC packages of E – Journals and has a good collection of CDs on various fields, text and reference books sections, multimedia e-learning sections. Our Library is equipped with the membership of National Digital Library of India (NDLI) and Membership of Developing Library Network (DeLNet).

Students can refer books, journals and magazines using college membership ID. In order to develop the English Speaking skills, Public Speaking Room (Mirror Room) is available at our central library and which has maximum utilization by our students.
